A new Prime Minister and revitalized Cabinet, an encouraging economic outlook, historically low unemployment, increasingly prescriptive (and arguably weakened) workplace health and safety legislation – not forgetting the latest bout of earthquakes – set the scene for an interesting 2017.

The regulatory 'step change' in our approach to reducing unacceptable workplace casualty lists is regrettably ushering in a new 'Risk Averse' era. More prescriptive legislation imposing additional responsibilities on directors and management, while allowing poorly performing industry sectors to escape the requirement for a trained health and safety representative and soon a competent chemical handler, will not deliver the sought-after reduction in workplace death and injury statistics.

Legislating for employees to be competent to safely manage chemicals and able to provide employers with prompt, onsite compliance advice (Approved Handlers) is a vital and necessary contribution to achieving the government's ambitious workplace casualty reduction goal. Relying on employers to voluntarily continue upskilling employees involved with chemicals is commendable but ignores increasing prosecutions arising from employers failing to honour existing and well-established legal obligations, such as paying staff the minimum wage, paying taxes and passing on employees' KiwiSaver contributions.

Our steadily increasing membership confirms conscientious employers recognize the need to keep abreast of changing workplace health and safety performance and compliance standards, reflected in the priority finally accorded to safely managing workplace chemicals.

Controversial chemical management regulations, further delayed due to their complexity, remain the priority for your Association's advocacy to not further degrade best industry practice in chemical safety under the guise of 'simplifying compliance'.

The overhaul of the faltering Test Certification regime is increasingly urgent as experienced Test Certifiers give up their licences. Your Association believes exchanging the flawed but ultimately effective mandatory Approved Handler requirement for a responsibility under general employer obligations to train employees, is high risk, undermines compliance and complicates enforcement.

Dow Chemical has launched a US\$ 206bn joint venture with oil giant Saudi Aramco to supply aromatic solvents, resins and isoprene to customers within

Plaschem Park, a huge chemical complex being developed in the Saudi coastal city of Jubail.

Dow Chairman and Chief Executive and previous ICCA Chair Andrew Liveris, will head US President elect Donald Trump's influential Manufacturing Council which advises the Secretary of Commerce on ways to revitalise US industry.

In response, Dow is building an Innovation Centre in Midland Michigan, while digesting the merger with Dow Corning.



Sustainability

Canada is to implement national carbon emission charges of CA \$10 per metric tonne in 2018 and progressively rising to CA \$50 per metric tonne by 2023.



Fossil fuel advocate and climate change sceptic Oklahoma District Attorney Scott Pruitt has been nominated to lead the US Environmental Protection Agency.



The World Meteorological Organization announced the hottest year on record, with temperatures 1.2°c above pre-industrial times. Warming will most affect the Middle East and India, however New Zealand will not be exempt. Elevated sea temperatures and rising carbon dioxide levels are expected to result in an increase to 0.95°c above the 1981-2010 average.



The future of the historic Paris Agreement, the first comprehensive climate pact supported by 194 signatories is in danger of being undermined by the proposed withdrawal of the United States.

The agreement recognises that urgent action is required to combat the human contribution to climate change is progress.



Ross Sea Sanctuary

The United States and New Zealand led the creation of the world's largest marine protected area, 1.55m square kilometres on the doorstep of Antarctica.

The 25 member Commission for the Conservation of Antarctic Marine Living Resources (CCAMLR) approved the Ross Sea Region Marine Protected Area, the habitat of iconic endangered Emperor penguins, Crabeater seals, orcas, and Minke whales.

Free Trade Setback

The proposed rejection by the incoming US Administration of the longawaited and hard-fought Trans Pacific Partnership (TPP) involving 12 Pacific Rim countries represents a major disappointment for free trade negotiators and a setback for globalisation.

Signed by the respective trade ministers in New Zealand in February 2016, the controversial agreement represents 40% of global trade and seeks to provide a comprehensive model trade pact acceptable to even the most protectionist administrations.

Given the reported pro-TPP views of key cabinet Trump appointees, it is perhaps premature to predict the demise of the ground-breaking agreement.

China is now expected to exploit the hiatus by actively pursuing the Regional Comprehensive Economic Partnership (RCEP) involving the 10 Association of South-East Asian Nations (ASEAN) member countries, together with regional trading partners China, Japan, South Korea, India, Australia and New Zealand. New Zealand is a foundation signatory.

Senior APEC officials meeting in Vietnam discussed the RCEP while voicing their concerns regional economic growth is threatened by stubbornly weak commodity prices and new fears of rising US protectionism. They propose a free trading bloc between Asia Pacific Economic Cooperation (APEC) members and the Pacific Alliance countries of Chile, Colombia, Mexico and Peru, with participants taking responsibility for identifying and encouraging initiatives to develop regional economic co-operation.

APEC Chairman, New Zealander Dr Alan Bollard notes APEC's voluntary, consensus-based approach to innovative policy making is well suited to identifying and expanding free trade opportunities. Given there will always be multi-national trade groupings, it seems counter-productive not to press ahead with free trade opportunities as they emerge. New Zealand continues to pursue bilateral trade deals in the Middle East, India, South Korea, the United Kingdom and the European Union.

Chief Executive Gordon MacDonald has returned to the UK after guiding a restructured WorkSafe NZ through the first 2½ tumultuous years, presenting the 'Regulator view' in various forums in a determined effort to improve understanding of the implications for businesses arising from the new Health and Safety at Work Act (HSWA) 2015.

Replacement Chief Executive Nicole Rosie, ex Director, Health and Safety at dairy giant Fonterra, takes up her new challenge this month.
